The Board of Trustees of the York Electric Cooperative met at the office of the Cooperative on Tuesday, November 26, 2019, at Noon for a luncheon. The meeting convened immediately after and was called to order by Chairman Jack Cornwell. Marc Howie provided the invocation. A quorum was present; therefore, it was in order to transact any necessary business of the Cooperative.

Denny Lynn, VP of Energy Delivery and Patty Moss, VP of Human Resources, provided a safety presentation that outlined many lineman training models, and the six standard incident ratings.

The Third Quarter 2019 Strategic Plan Update was approved.

The 2020 Strategic Plan was approved.
